### Acknowledging First Nations, Métis, and Inuit Peoples

After being recommended by Town Councillor Edie Yuill and research and recommendations by a Council sub-committee, the Town now has an official Land Acknowledgement statement to properly acknowledge First Nations, Métis, and Inuit Peoples.

The acknowledgement will be included on the Town website and social media accounts and will be recited with due respect prior to all Council meetings and official gatherings. The acknowledgement says:

The Town of Athabasca respectfully acknowledges that we are meeting on Treaty 6 and Treaty 8 territory, home to the First People living on Turtle Island, and we honour all of the First Nations, Métis, and Inuit peoples who have lived, traveled, and gathered on these lands for thousands of years. We commit to sharing a path forward of respect, learning, and opportunity.

### **Healthcare Attraction Committee**

Last year, the Athabasca Regional Healthcare Attraction and Retention Committee was established to begin a determined search for doctors and other healthcare professionals for the Athabasca region. Town Council is grateful for the effort put in so far by each of the committee members, in particular, the public members who freely contribute their time and attention.

The committee comprises support and representation from the Town of Athabasca, Athabasca County, Village of Boyle, MD of Opportunity, Buffalo Lake Metis Settlement, health care representatives, public members and others. Council is pleased to note that the efforts of the committee are showing results! Doctor Paras Shrestha began practice in Athabasca in August and another new doctor is expected to arrive early in January 2023.

With the purpose of the committee being to "develop and support a sustainable system for health care provider attraction and retention that will ensure ongoing health care services to the community," finding new doctors was the first priority, to be followed up with a focus on filling other healthcare positions where needed.

Beyond the immediate need, the committee realizes that it's not only the doctors who must be attracted to the community, but their families must also be interested and may benefit from supports and assistance to help them feel more engaged and connected to the community.

With communities throughout the province equally engaged in attraction and retention efforts, members of the Athabasca committee have their work cut out for them! Their efforts to date are to be commended and are very much appreciated.

### Town Strategic Plan 2022-2032

Many factors were taken into consideration when drafting the Town's long-term strategic plan to ensure that the Town continues to prosper over the next 10 years. Four strategic goals were established, each one highlighting a different aspect of life in the Town. Ranking goals provides Town administration with clarity on where the most value exists when building business plans and budgets. The goals are designed to encompass future developments or opportunities.

#### **Four Strategic Goals:**

- Infrastructure: We will plan and prioritize long-term infrastructure decision-making.
- · Have an asset management plan.
- Decisions are made using evidence & subject matter expertise.
- Community has confidence in our infrastructure.
- Our assets enhance community beautification.

Investing in assets for the community is a critical job of Council. As such, we place an emphasis on acquiring infrastructure that aligns with what our citizens see as important. We must also keep a keen eye on what the future holds for communities. We will attempt to secure grant dollars to maximize value and continue to move towards responsible energy management.

- 2) Well-Being: Our role as stewards in championing community well-being is easily recognized.
- Our financial reserves are healthy.
- We are an attractive community for business, residents, visitors.
- Our citizens have a sense of safety.

When we were strategic planning, we started by asking ourselves why does a municipality exist. For Council, our job is to provide the best long-term well-being for our community and its citizens. We are determined to have a great conversation with the community about how we are doing in this regard.

- 3) **Leadership:** We are committed to strong governance through building community leadership.
- Clarity in council roles and responsibilities.
- · Assessment growth.
- Population growth.
- Proactive agreements with other orders of government.
- The community feels they've had an opportunity to contribute.

Elected officials are chosen to represent their community. A big part of demonstrating leadership is to work with all stakeholders to grow the community. # Clean Energy Improvement Program Launching in Athabasca

Soon to be available to Town residents, a different kind of financing for renovations that make a difference.

The Clean Energy Improvement Program (CEIP) is a new way to finance energy efficiency and renewable energy upgrades. Repayment is made conveniently through your regular property tax bill and interest rates are competitive. What's more, repayment is tied to the property, not the owner—so you can invest in money saving upgrades now, without worrying about what happens when the property sells.

The <u>CEIP website</u> notes that, "This innovative financing approach, also known as *Property Assessed Clean Energy* (PACE), is garnering successful results across North America. This is the first such program in Alberta and is available now in select municipalities."

Renovations that may qualify include adding insulation, replacing furnaces and hot water heaters, upgrading doors and windows, and adding solar photovoltaic systems.

Benefits include lower utility bills, higher property value because of the upgrades, and jobs in the community.
