

## SCHEDULE A

- a) As referred to in Section 6.2, the minimum charge for water service shall be set at \$26.88 per billing (5 m3).
- b) As outlined in Section 6.2, a charge shall be levied on all metered water in excess of minimum usage as follows:

**18 m3 or less \$5.3760/m3**  
**18.1 – 45 m3 \$5.5335/m3**  
**Over 45 m3 \$6.0921/m3**
- c) The penalty on arrears for all water and sewer services shall be 3.5% per billing.
- d) A fee of \$100.00 will be levied if the owner has requested the services be Shut Off.
- e) All new owners of a parcel of land requiring municipal utility services shall pay a \$50.00 non-refundable administration fee.
- f) All new accounts that require municipal utility services shall pay a \$50.00 non-refundable administration fee.
- g) The sewer rate outlined in Section 6.3 shall be 36.00% of water consumption charge for that billing period.
- h) Users of the sewage dumping station (other than R.V.'s) as outlined in Section 5.3 shall be charged at a rate of \$5.20 per tip or \$7.30 per 1,000 gallons of sewage, whichever is greater.
- i) If utility services are currently provided to a parcel of land on the request of the owner, and the utility services are unpaid on the due date of any billing, a reminder letter will be sent. If they are still unpaid after an additional ten (10) business days, the outstanding balance plus a \$50.00 Administration Fee shall be transferred to taxes.
- j) The rate for bulk water, referred to in Section 4.15, and water that is for resale shall be set at \$10.00 per cubic meter.
- k) The metered sewer rate for the Aspen Regional Water Services Commission shall be the sewer rate (36.00%) calculated at the base water rate of \$1.9354/m<sup>3</sup>.
- l) Town Operator visual investigative assistance regarding Utility Service(s) shall be charged at an hourly fee, per hour, in an amount equal to the highest applicable hourly rate for an operator set out in a salary grid as established by the Town, as amended from time to time. One (1) hour minimum.
- m) Water Meter Proving deposit - \$150.00
- n) Water Meter Data Log request - \$50.00 per data log requested.
- o) Meter removal prior to structural demolition shall be charged at an hourly fee, per hour, in an amount equal to the highest applicable hourly rate for an operator set out in a salary grid as established by the Town, as amended from time to time. One (1) hour minimum.
- p) Closed Circuit Television (CCTV) inspection of sanitary Service Line - \$450.00 up to 100 feet for the 1<sup>st</sup> hour.

Every subsequent hour thereafter shall be charged at an hourly fee, per hour, in an amount equal to the highest applicable hourly rate for an operator set out in a salary grid as established by the Town, as amended from time to time. One (1) hour minimum, subject to the percentage tiers as described in Section 5.1.
- q) Power auger sanitary Service Line:
  - i) Arrowhead only, single run out and retract - \$550.00 up to 100 feet for the 1<sup>st</sup> hour.

Every subsequent hour thereafter shall be charged at an hourly fee, per hour, in an amount equal to the highest applicable hourly rate for an operator set out in a salary grid as established by the Town, as amended from time to time. One (1) hour minimum, subject to the percentage tiers as described in Section 5.1.

OR

ii) 2 inch or larger cutting attachment, maximum 2 run out and retract - \$650.00 up to 100 feet for the 1<sup>st</sup> hour.

Every subsequent hour thereafter shall be charged at an hourly fee, per hour, in an amount equal to the highest applicable hourly rate for an operator set out in a salary grid as established by the Town, as amended from time to time. One (1) hour minimum, subject to the percentage tiers as described in Section 5.1.

r) Line Thawing - \$550.00 up to 100 feet for the 1<sup>st</sup> hour.

Every subsequent hour thereafter shall be charged at an hourly fee, per hour, in an amount equal to the highest applicable hourly rate for an operator set out in a salary grid as established by the Town, as amended from time to time. One (1) hour minimum.

s) A utility distribution charge of \$25.00 per billing will be charged on all water service meters.
